



United States Export Regulation Compliance

End Use / End User Certificate

To Whom It May Concern:

It is Sorkness Aviation, Inc. policy to verify the end use and end user in all sales and repairs of Sorkness Aviation, Inc. supplied products and in all transfers of technical data or software to ensure compliance with applicable U.S. export control laws and regulations. Because the products you are purchasing may be exported and used outside of the United States, please confirm the following:

1. I (We) will not export or re-export any Sorkness Aviation, Inc. supplied products, technology or software to Cuba, Iran, Iraq, Libya, North Korea, Sudan, or Syria, unless otherwise authorized by the United States Government.
2. I (We) will not sell, transfer, export or re-export any Sorkness Aviation, Inc. supplied products for use in activities which involve the development, production, use or stockpiling of nuclear, chemical or biological weapons or missiles, nor use Sorkness Aviation, Inc. supplied products in any facilities which are engaged in activities relating to such weapons.
3. I (We) acknowledge that U.S. law prohibits the sale, transfer, export or re-export or other participation in any export transaction involving Sorkness Aviation, Inc. supplied products with individuals or companies listed in the U.S. Commerce Department's Table of Denial Orders, the U.S. Treasury Department's list of Specially Designated Nationals or the U.S. Department of State's list of individuals debarred from receiving Munitions List items.
4. I (We) will abide by all applicable U.S. export control laws and regulations for any products purchased from Sorkness Aviation, Inc. and will obtain any licenses or prior approvals required by the U.S. government prior to export or re-export of Sorkness Aviation, Inc. supplied products, software or technology.
5. I (We) agree that the export control requirements in items No. 1-4 above shall survive the completion, early termination, cancellation or expiration of the applicable purchase order, agreement or contract.
